The recovered data will keep on our company for 3 days since data delivered to Customer and after that the data will be automatically deleted. So, if there is any discrepancies found from the recovered data, you have to contact us within thi period of 3 days, Also customer, articles will be scrapped out at our side without any pre-notification, if customer do not response with in 2 weeks after CU report the result of DR operation. Data Recovery fee will be varies with the kind of device, OS, files system, and capacity of devices but not with amount of data. For the urgent and Holiday's service request, will charge moure additional 30% of normal recovery fee.
